## GIVESENDGO CHARITIES

### SCHOLARSHIP GUIDELINES & POLICIES

#### **Scholarship Funds**

Any Scholarship Funds must be established to support individuals in furthering their educational endeavors.

1. These funds may be used to support education in any form, including private schools, educational organizations, mentorship programs, or any group that seeks to advance education in a particular field.
2. Scholarships are awarded to qualified individuals who have completed the corresponding scholarship application.

#### **Unique Scholarships vs. General Scholarships**

Our Charity seeks to provide several avenues in which charitable endeavors may continue, which includes our Scholarship programs. At any time, we may establish a unique or general scholarship to help further our charitable mission.

1. **Unique scholarships** address a specific financial obligation to a specified educational institution or program.
  1. Partnerships between the charity and the educational institution/program may be formed to advertise and grow the scholarship.
  2. The institution has no say in who will qualify for the scholarship.
2. **General scholarships** cover a variety of educational institutions, such as scholarships for bible schools or mission schools.

#### **Selecting Scholarships**

All of our Scholarships must be crowdfunded to meet the charity's charitable purposes. Scholarships can be connected to a particular institution or program for higher education or may cover a general education category like Bible Schools. We primarily focus on faith-based education but are not limited to it.

Any institution or program the scholarship is applied to must have good public visibility, credibility, and a decent public following.

#### **Scholarship Management**

Our charity sets up the scholarship and allows its fund to grow through the crowdfunding site GiveSendGo.com.

Each scholarship has specific criteria that must be met for an application to be approved. Scholarships cover either half or the whole of an essential cost, depending on the institution.

#### **Scholarship Oversight**

Each scholarship has a committee that reviews and selects winners based on academic achievement in the field of interest.

The charity does not discriminate against anyone applying, but each applicant must meet the criteria for approval.

#### **Donations to Scholarships**

All contributions to a scholarship are tax-deductible to the full extent of the law.

The charity collects a 3-7% administration fee and goes toward furthering the charity's mission.

### **Scholarship Distributions**

Scholarships are distributed as grants to individuals who must prove their acceptance into the program and their need for the scholarship.

Each grantee must confirm the specified use of the scholarship to the charity.

### **Dissolution of a Scholarship**

Suppose at any time a scholarship program is found to meet the charitable nature of our organization no longer or becomes no longer necessary for any reason. In that case, the funds will be allocated to our GiveArmy "Education" Cause and disbursed as grants to qualifying individuals.

### **Privacy Policy**

**Eligibility Criteria:** Each scholarship fund will have clearly defined eligibility criteria that outline the minimum requirements applicants must meet to be considered for the scholarship. These requirements may include academic achievement, financial need, community involvement, and other relevant factors to the scholarship fund.

**Selection Process:** Each scholarship fund will have a clearly defined selection process that includes the composition of the selection committee, the criteria used to evaluate applicants, and the timeline for selecting recipients. The selection process will be transparent, fair, and based on merit.
